- Please note: Anyone that has missed the orientation session for the upcoming EMT-I Class for 2016 may <u>email EMS Lt. Len Stewart</u>. You must be affiliated with a Baltimore County career or volunteer company to participate. Each individual must submit a cover letter and a letter of recommendation from their station officer and career EMS District Officer/Liaison.
- The MFRI ALS Refresher has been posted on the MFRI website. Registration started July 1, 2015. Each class must have a 15 person minimum to be held due to the number of

- There are 16 students that remain in the current EMT-I class and have finished class lecture. Students are finishing up their clinical hours with their preceptors and MUST have hospital clinics done prior to taking the National Registry Practical.

- Registration will be available online beginning July 1 through MFRI, select <u>Course</u> <u>Listings</u> to start your registration.
- All career members who wish to take MFRI courses which require medical clearance should submit a MFRI Appendix B to the Chief of Training to be completed and signed. In the absence of the Training Director, the Chief of Safety will complete the forms. It will no longer be necessary for personnel to take the Appendix to their primary doctor, the annual medical compliance form can be used to validate this information. 
RECOGNITIONS
